- 6) In-situ calibration arrangement: Preferably Min 10 days' notice
- 7) This requirement will valid for 2 years for all future jobs until and unless informed
- 8) CT Services (M) Sdn Bhd shall sub-contract the calibration to approved sub-contract due to unavailability of standards or scope of calibration but subjects to customer agreement
- Item(s) not collected within 6 months from completion date will be consider as scrap and removed from CT Services (M) Sdn Bhd
- 10) If the item is found to be out of specification/tolerance, CT Services (M) Sdn Bhd will seek advice from customer for the adjustment on the item
- 11) Lab by default will not provide a Statement of Conformity unless requested by customer. If needed, please contact respective sales/quality person for further discussion
- 12) Item calibrated under SAMM requirement is subject to calibration range and the scope of accreditation
- 13) Standard calibration parameter will be performed unless requested otherwise
- 14) No claim will be entertained after 2 weeks after receive the item calibrated
- 15) Item send to CT Services (M) Sdn Bhd MUST be in decent working condition and come in complete set of accessories/manual/ related documents to carry out the calibration
- 16) Calibration charges will not be charged only for spoilt item when received, equipment with error out of specification will be charged as normal
- 17) Cancellation for flowmeter calibration will be charged full if the job has been done as huge amount of time needed to setup the calibration facility
