Should there be any damage to the tool during the rental and/or transport, its repair/or Replacement price will be charged to the LESSEE in addition to the rental rate. Therefore, the LESSEE must cover any damage or loss by contracting insurance, where GTA will be designated as beneficiary (**Insurance value RM 350,000.00**) However, lack of or insufficient insurance coverage does not release the LESSEE from its obligations.
4. Maximum rental period of above equipment: 14 days. Beyond this period, an additional cost will apply to the weekly rental rate and shall inform GTA on the extended days of rental.

6. If the Lessee returns the tool within the same day as the pickup date a charge of 1-day rental rate shall be applied.
