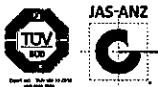

2. If customs clearance is selected as part of our services at the booking stage, please ensure that all mandatory documents required for custom clearance is provided 5 working days before the vessels estimated time of arrival (ETA) at the Port of Loading.
3. All personal effects/packages which are to be shipped together with your vehicles must be declared. A non-declaration of personal effects/packages, will result in your vehicles not being cleared at the Port of Discharge and the vehicle may be compounded by the Port Authorities. Please note that, you are advised to take the necessary precautions, whether by purchase of insurance and adherence to lawful safety rules & regulations, with regards to the items that you may ship within your vehicles. Giga Maritime Group will not bear responsibility or be held liable for any losses, damages or penalties incurred to the personal effects/packages throughout the process of shipment and delivery.
4. A Surrender Fee of RM50.00 per set will be applied if customers which to surrender their Bill of Lading at loadport.
5. The rates quoted within this Quotation No : GSQT072000157, excludes any additional equipment which may be required during the loading and/or discharging operations (for High and Heavy vehicles). All equipment, which are deemed necessary for movement of the High and Heavy unit, will be arranged and the additional charges will be advised for billing.
6. Unless Marine Insurance Coverage is selected from our list of services, it is the Shippers responsibility to ensure that their cargo is adequately protected and insured against all risks until its arrival at the Consignee's door. Storage

1. Seven days of free storage is provided at Giga Car Terminal (GCT), Westports, Port Klang for vehicles on the domestic export route from Port Klang to East Malaysia. Should the storage period exceed seven days of the free storage provided, then a storage fee of RM8.00 per unit / per day, will be incurred from the 8th day of storage onwards. (Domestic Export – Port Klang to East Malaysia)
2. Three days of free storage is provided at Giga Car Terminal (GCT), Westports, Port Klang, for vehicles on the domestic import route from East Malaysia to Port Klang. Should the storage period exceed the three days of free storage provided, then a storage fee of RM8.00 per unit / per day will be incurred from the very first day of storage. (Domestic Import – East Malaysia to Port Klang).

Payment Terms

1. For non-credit customers, payment are to be made in "CASH" or through issuance of a current company cheque. Please issue the cheque 3 working days prior to the vessels' departure date from Port Klang to avoid any storage or double port charges etc. Giga Maritime Group will only release the Delivery Order to the consignee at the Port of Discharge, once the cheque is cleared by the bank.
2. In the event of the introduction or imposition of new and revised taxes, tariffs and/or a petrol/diesel hike by the Government, Giga Maritime Group has the right to revise the rates of services affected by the Governmental changes made.
