Subject : COVID-19 MANDATORY COMPLIANCE

With regards to the recent COVID-19 Monitoring Visit and compound issued by MITI, we would like to inform all personnel to comply with relevant COVID-19 SOPs by the authorities. Mandatory SOP that needs to be complied by personnel and workplace in order to prevent the COVID-19 disease are as follows but not limited to:

- 1. Always wear a face mask (usage of double face mask is highly recommended),
- 2. Scan MySejahtera Apps while entering the premise (check-in & check-out),
- 3. Conduct sanitation process at least 3 (three) times a day and records must be made available,
- 4. Practice social distance with at least 1 meter from others,
- 5. Make a demarcation for social distancing i.e., meeting rooms, surau, pantry, smoking areas, etc.,
- 6. Perform the RTK Self-Test as per schedule (fortnightly),
- 7. Only personnel with "low risk" status and temperature below 37.5°C are allowed to enter the workplace.

You shall comply with the above requirements and other all relevant COVID-19 SOPs, or <u>you may subject to company disciplinary action including penalty and/ or back charge of the fines/ compound issued by authority for the breach of SOP. Attached herewith, please find the COVID-19 poster and compound receipt for your record and reference.</u>
