3. INTRODUCTION

Galaxy Aerospace Malaysia Sdn Bhd would like to announce a new vacant position of CAM Manager for Galaxy's non-AOC CAMO. Galaxy would like to fill the position internally if possible. Work experience, seniority, and performance will all be determining factors. The Human Resources department will be screening candidates in coordination with management.

4. REQUIREMENT

This person is the nominated post holder for continuing airworthiness activities. He/She will, ensure that all continuing airworthiness activities including maintenance is carried out on time and to an approved standard. He / She will act to ensure that Galaxy Aerospace Malaysia Sdn Bhd responsibilities in the following areas can be met:

- Establishment and development of continuing airworthiness policy, including the approval of Galaxy Aerospace Sdn Bhd aircraft maintenance programmes required by CAAM continuing airworthiness requirement;
- As CAAM Post Holder he/she will be the communication point of contact between CAAM Airworthiness Sector and Galaxy on CAMO matters;
- 3. Analysis of the effectiveness of the Maintenance Programme as required by CAAM continuing airworthiness requirement;
- 4. To liaise with client on all airworthiness matters as required;
- 5. To ensure all aircraft managed by GAM CAMO is under contract requirement as per AN 6101
- 6. The relationship with CAAM AMO and if applicable establishment of a Maintenance Contract as required by CAAM continuing airworthiness requirement;
- 7. Ensuring that the continuing airworthiness required by CAAM is effective in its application and any follow up actions required to address findings;
- 8. Manage the approval of Galaxy Aerospace Malaysia Sdn Bhd Aircraft Journey Log by CAAM including any subsequent amendment thereto;

- Ensuring that Galaxy Aerospace Malaysia Sdn Bhd technical records are managed as required.
- 10. Manage planning coordination on the required work with the maintenance organisation;
- 11. Ensure modifications and repairs (changes) are carried out to an approved standard;
- 12. To ensure all Airworthiness Directives review and embodiment;
- 13. To carry out Non mandatory modification embodiment policy;
- 14. To ensure all defect rectification carried out as per approved data;
- 15. Ensure line and base maintenance are performed by appropriately CAAM AMO;
- 16. Ensure that operators pilots are duly trained and authorised to issue Certificates of Release to Service, where necessary and appropriate, by the CAAM AMO;
- 17. The Certificate of Airworthiness for each aircraft operated / managed by the Galaxy remains valid in accordance MCAR 2016, Regulation 27;
- 18. To report any occurrences of a maintenance nature to the CAAM and the aircraft manufacturers. This includes both Mandatory Occurrences and occurrences related to maintenance findings, which fall outside the Mandatory scheme;
- 19. The amendment and control of this Continuing Airworthiness Management Exposition;
- 20. Review and implementation, as appropriate, of any additional CAAM requirements;
- 21. The CAM shall nominate personnel to deputise for any period of absence in the case of AM not available;
- 22. Manage the application of Permit to Fly (PTF);
- 23. To ensure Airworthiness Review and Physical Survey of the aircraft has been carried out as per CAAM continuing airworthiness requirements;
- 24. To ensure all maintenance are being carried out by an CAAM AMO;
- 25. To ensure adequate office accommodations for continuing airworthiness activities;
- 26. To ensure the extension of a MEL item is applied correctly
- 27. The manage the amendment and control of the MEL and maintenance programme;
- 28. To ensure that weighing of aircraft is carried out in a timely manner by organisation approved by CAAM and the RFM is updated with current weighing data;
- 29. Responsible to control the competency of continuing airworthiness personnel;
- 30. To control and maintain on maintenance data, procedures and forms for continuing airworthiness activities;
- 31. To ensure all contracts related to continuing airworthiness and maintenance meets the CAAM requirements.
- 32. To ensure all the operational requirements by the operator are within the compliance of CAAM regulations
