2. APPLICABILITY

- a. All aircraft managed by GAM CAMO

3. INTRODUCTION

- a. Technical Record are responsible to ensure that [Aircraft Certificate File](#) is required to be carried on board in accordance with [CAMP Chapter 2.5.4](#).
- b. This notice is revised to introduce new [form GAM/C-058 Rev 0 \(10/23\)](#) to ensure compliance with the above requirements for aircraft certificate file.
- c. The compliance to this procedure shall be effective [7 days from the revision date of this notice](#) and shall be integrated into the upcoming revision of CAMP.

4. REQUIREMENT

- a. In addition to [CAMP Chapter 2.5.4](#), Technical Record personnel shall [raise form GAM/C-058 Rev 0 \(10/23\)](#) for each aircraft to ensure that all certificates and documents as listed in [CAMP](#) are carried on board and update to the latest issuance or revision.
- b. Any certificates or documents that are not applicable to aircraft shall be stated in the remark accordingly.
- c. Refer attached [form GAM/C-058 Rev 0 \(10/23\)](#) and its instructions for reference. The form can be accessed via [GAMS portal](#) under [Publication > Forms > CAMO](#).
