Subject : Covid-19 Safety Measures

- 1. Due to recent increasing number of cases regarding Covid-19, This memo is for reminder to all staff as a safety measures due to "new normal" that we are facing right now. All employees are required to comply with the SOP's that have been implemented during the period of the Covid-19 control order by maintaining personal hygiene and avoiding 3C:
 - Crowded Places (stay away from crowded areas).
 - *Confines Space* (avoid confine areas and ensure 1-meter distancing).
 - *Close Conversation* (avoid chatting or talking at close range).
- 2. With refer to the current situation, all activities performed at GAM must take into account the outlined SOP's by *Ministry of Health Malaysia* (*KKM*), *National Security Council* (*MKN*) and a company's directive, such as trainings, meetings or other activities involved the crowds. All employees should take the responsibility for the safety of themselves, families, and other employees in the company by considering:
 - Limited the participant for the trainings or introduced online trainings.
 - Limited the participant in the meeting or introduce online meetings.
 - Reconsider the off-base travelling especially to the red zone area.
 - Postponing or cancelling a non-urgent trip or vacation.
- 3. Other than that, we are also to comply with all instructions and guidelines issued by KKM to stop the spread of Covid-19 virus in our company. Therefore, all employees must do following practices,
 - Frequently washing hands with water and soap or use hand sanitizer.
 - Always wearing face mask especially when having a discussion.
 - Practice caution by avoiding handshakes, staying at home and seeking treatment if you are developing symptoms related to Covid-19.
 - Use your own prayer mat or telekung to perform prayers.
- 4. Besides that, if employees have a close contact with the positive Covid-19 carrier or instructed to resume a health check at the hospital for Covid-19 test, please report to the company immediately and comply with the prescribed quarantine period with refer to:
 - HR DIRECTIVE 2020-011 COVID HOME SELF QUARANTINE (HSQ).
 - ADMIN DIRECTIVE 2020-005 CORONA VIRUS 2019 (COVID19).

- 5. All directive issued by the company will be enforced effective immediately. All employees are responsible to follow all the instructions and guidelines that have been set by the company. Those who found guilty and did not follow the SOP and instruction given, company will take an immediate action due to negligence act to the company.
- 6. In the same regard, seeking all departmental head to disseminate this information to their subordinates and to paste this memo onto your respective notice board.
