Regulation 7 of Malaysian State Technical Airworthiness Requirement Part 66 (MSTAR-66) pertains to the State Aircraft Maintenance License (SAML). Its primary objective is to enforce the requirement that technical personnel engaged in the upkeep of state aircraft hold a Personnel Licensing.

Approval Authorization Certifications may be issued by AMO to authorized technical personnel who meet the following criteria:

- Aviation Engineers who are authorised to certify the airworthiness status of aircraft through the issuance of Certificate Release to Service (CRS),
- Support Staff who are authorised to sign off on aircraft maintenance records,
- Certifying Staff who are authorised to verify aircraft maintenance release records.

Commercial organizations and SAOs that possess the AMO and AMTO certifications are obligated to adhere to and execute the TAAC requirement in a corresponding manner. An offer of exemption privileges to a SAML application, as defined in paragraph 11 of the TAAC-T-003, shall remain in effect for a period of three (3) years from the date of implementation and expiration on 31st May 2024.

For the SAML application, the following forms and logbook must be completed:
