- 2. JBPM's AW139 Reg: 9M-BOD is currently down at JBPM Bertam due to defective Data Collection Unit (DCU). In addition, the aircraft has been planned for 1 Y, 600 FH/1 Y, 600 FH, 400 FH and 450 FH/18 months inspection ,which is estimated to be down for 7 days from 14/9/2021 until 20/9/2021. Due to contractual obligation with JBPM which prevents us from grounding the aircraft for an elongated period per month, we are planning to carry forward several maintenance, which will be done alongside the defect rectification at JBPM Bertam.
