An internal audit of Galaxy Aerospace (M) Sdn Bhd CAAM Approved Maintenance Organisation (Part 145) was performed on 10th September 2019 at Galaxy Aerospace (M) Sdn Bhd HQ office, Suite 11-14, Helicopter Centre, Malaysia International Aerospace Centre Sultan Abdul Aziz Shah Airport, 47200, 47200 Subang, Selangor. The GAM QA auditor consist of Adib Nafie Bin Ahmad Yunus (QAI) and Mohamad Amirul Hakim Bin Zulkufli (QAA).

The internal audit was mainly to evaluate Galaxy Aerospace as an acceptable GAM-145 for Bell Helicopters 429 prior to submission application to Civil Aviation Authority Malaysia (CAAM). The focus of audit is to evaluate GAM-145 as capability to provide maintenance related function, due to raise of Management of Change (MOC).

The audit methodology are through documents review, interview with key personnel and observation at the work place. Reference was made to the CAAM Malaysia Civil Aviation Regulations and Airworthiness Notices for compliance.

A. COMPLIANCE WITH DCAM NOTICE 6501

i. Notice 6501 Compliance Checklist was referred. (Ref. 10)

- ii. With regards to (Ref. 10), it was found that most of the basic requirements checklist from AN6501 are comply by GAM-145.
- iii. The aircraft Bell 429, AC Reg. 9M-PEC is currently owned by PLUS Helicopter Sdn. Bhd.
- iv. The aircraft Bell 429 (9M-PEC) is already contracted its CAMO with GAM-CAMO since May 2019.
- v. Therefore, PLUS Helicopter is intent to engage with GAM-145 for its aircraft maintenance activity.

B. MAINTENANCE DATA

- Technical publication for BELL 429 helicopter and P&W subscribed by GAM CAMO and distribute to GAM AMO.
- ii. Publication Master Listing is obtain from GAM-CAMO as GAM-CAMO is the CAMO provider for Bell 429. (Ref. 5)
- iii. Publication Master Listing is cross referred with existing publication (hardcopy and softcopy).
- iv. Maintenance manuals for Bell Helicopters 429 is found updated.
- v. Refer enclosed List of Publication Master Listing (Ref. 5) for details.
- vi. Production Planner of GAM-145 is to ensure that Publication Master Listing and updated maintenance publication reference to be ready at maintenance working area.

C. PERSONNEL

- i. List of Approval Holder (Ref 4) was referred.
- ii. The nominated maintenance personnel for Bell 429 as per below:

- iii. Based on the nominated personnel, GAM-145 consist enough certifying staff to carry out maintenance certification on the aircraft.
- iv. Unfortunately, full man-hour plan including support staff for the applied aircraft Bell 429 maintenance is not available and updated.- NCR No.1 Raised
- v. Man-hour for section Production Planning, Technical Record and Logistic section also is not available.

D. FACILITIES

- The aircraft Bell 429 is planned to be perform maintenance at approved maintenance location in UniKL Miat Subang Hangar 2.
- ii. UniKL Miat Subang Hangar 2 is currently an approved hangar for GAM-145 to perform line and base maintenance for the aircraft of AW139, AW189, EC120B, R44, and R66.
- iii. Hangar size found sufficient, proper docking/maintenance platform available. GAM's facility at MIAT Hangar including store, holding area and office were found to be sufficient for the maintenance and parking of the type of helicopter in request.
- iv. Even the hangar found sufficiently enough to accommodate, GAM-145 need to do proper segregation for difference type of aircraft.
- v. The concern is due to increasing number of aircraft, and if all aircraft is down for maintenance at the same time. Current justification is consider enough due to serviceable aircraft is not parked at UniKL MIAT Hangar 2. **Noted in Observation**.

E. TOOLS AND EQUIPMENT

- Three type of tools identified for the purposes of Bell 439 aircraft maintenance under GAM-145 which are General Tools, Calibrated Tools, and Special Tools.
- ii. For General and Calibrated Tools, documents item 11 and 12 are referred.
- iii. Calibrated tools was found up-to-date and controlled.
- iv. General tools and calibrated tools found sufficient for aircraft Bell 429 maintenance purposes.
- v. As per MOC raised (Ref. 1), it was mentioned that special tools i.e. high frequency usage tools are required. GAM-145 plan to purchase or rent/loan the special tools. Purchase order or tools agreement / letter of support is not available. NCR No.2 Raised
- vi. For test equipment, it was mentioned that it is partially available in tools store as per attached list. GAM-145 justify that the equipment will be purchase or rental/loan from other organisation. Purchase order or tools agreement / letter of support is required. Refer NCR No.2.

F. PRODUCTION PLANNING

- Maintenance data in the form of maintenance manual is stored in the form of soft copy at designated registered PCs. Access to the maintenance data is available to GAM personnel, and is updated every time new publications are released by production planner, in accordance with EPM 3-01, Publication and Maintenance Data Flowchart.
- ii. Workpack and worksheet raised by maintenance planner is hand over to production planner. Production planner will then check the documents before handing over and distribute to GAM-145 maintenance personnel to perform aircraft maintenance.
- iii. After completion of maintenance, the production planner shall ensure that all the worksheet have been closed and completed.
- iv. The production planner will check the documents for any discrepancies. Once satisfied, the production planner will make a copies, and the original documents will be pass to CAMO for storage of record.
- v. "The organisation shall have a system appropriate to the amount and complexity of work to plan the availability of all necessary personnel, tools, equipment, material, maintenance data and facilities in order to ensure the safe completion of the maintenance work." – AN6501 Para 7.7(a) Found Satis

2. Findings / observation

Observation:

- The approved aircraft maintenance location of GAM-145, UniKL MIAT Hangar 2 is found satisfactory for aircraft Bell 429 parking and maintenance. But, it is concern in the future that the facilities size might not be enough to accommodate due to increasing number or aircraft manage under GAM-145.
- 2) Current justification that the facilities is enough to accommodate the aircraft is because most serviceable aircraft are parked outside facilities or at other places. The concern comes if all the aircraft down for maintenance at the same time which would consume high facilities space thus, disturb the maintenance activity.
