8. Occurrence Definition 90100076 applicable to AVN1C.
9. TEMPORARY TOTAL DISABLEMENT, means disablement which entirely prevents an Insured Person from attending to their usual duties.
10. PERMANENT TOTAL DISABLEMENT, means disablement which entirely prevents an Insured Person from attending to their usual duties lasting twelve calendar months and at expiry of that period being beyond hope of improvement.
11. LOSS OF LIMB, means loss by physical separation of a hand at or above the wrist or of a foot at or above the ankle and includes total and irrecoverable loss of use of hand, arm, foot or leg.
12. Crew Personal Accident coverage extended to include personnel of the Civil Aviation Authority of Malaysia.

In consequence, an additional premium at contract terms is due from the Insured.

All other terms, clauses and conditions remain unaltered.
