

Appointment as Member of Safety Action Group (SAG)/ Health, Safety, Security, and Environment (HSSE) Committee

Please be informed that you have been appointed as a member of the SAG/HSSE Committee, representing GAM AMO Office, Agensi Penguatkuasaan Maritim Malaysia (APMM) - AW139 Subang effective from 18th December 2023. You are directly report to the Chairman of SAG/HSSE Committee for any HSSE related matters.

- 2. The SAG/ HSSE Committee has several responsibilities under the Civil Aviation Directive 19 (CAD-19), Civil Aviation Guidance Material 1902 (CAGM -1902), Occupational Safety and Health (OSH) Act and Regulations, Environmental Quality Act & Regulations, and other related legal & other requirements which included but not limited to:
 - a) Assist in the development of safety and health rules and safe systems of work.
 - b) Review the effectiveness of the specific safety risk controls and safety & health program.
 - c) Conduct studies on accident trends, near-miss accidents, dangerous occurrences, occupational poisoning, or occupational diseases that occur at the workplace and shall report these findings along with recommendations for corrective actions.
 - d) Review the safety and health policies at the workplace and providing recommendations to the employer for any necessary revisions.
 - e) Monitor operational safety performance within their functional areas of the organisation and ensure that appropriate safety risk management activities are carried out.
 - f) Review available safety data and identify the implementation of appropriate safety risk control strategies and ensure employee feedback is provided.
 - g) Assess the safety impact related to the introduction of operational changes or new technologies.

- i) Assist to comply to the relevant environmental legal requirements.
