INSTRUCTIONS FOR FILLING OUT THE GAM/E-049 GROUND RUN/TEST FLIGHT REPORT FORM.

CONTINUE FORM PREVIOUS FORM NO:	Insert the number of the previous form consecutively, continuing from the last form used.
FORM NO.	Insert the form number consecutively, following the sequence of previous forms.
DATE:	Insert the date when the aircraft ground run or test flight is scheduled to be carried out.
A/C HRS:	Insert the current total hours accumulated by the aircraft.
WORKSHEET REF.:	Insert the associated worksheet reference number that relates to the task being documented.
WORK / TASK PERFORMED	Insert a description of the work or task that is to be performed during the ground run or test flight.
DESCRIPTION OF TEST REQUIRED OR REF.:	Insert the test that is required or provide the reference for the test during the ground run or test flight.
FURTHER GROUND RUN REQUIRED?	Tick "YES" if a further ground run is required; tick "NO" if it is not.
FURTHER TEST FLIGHT REQUIRED?	Tick "YES" if a further test flight is required; tick "NO" if it is not.
PILOT SIGN	The pilot performing the activity must sign here.
AUTH	Insert the pilot's authorization, confirming their authority to carry out the task.
LAE / AH SIGN	This section must be signed by the Licensed Aircraft Engineer (LAE) or the authorized approval holder involved in the activity.
APP / STAMP	Insert the approval or stamp of the LAE or approval holder, verifying the completion and accuracy of the form.
