

Airbus Helicopters would like to inform you through the Orolia Service Letter (see attached document) of the change in the procedure to follow when an aircraft needs to change the ELT beacon battery.

Besides opening the ELT and replacing the battery, the full ELT battery replacement process includes complete testing of the ELT's performance, in order to make sure that your ELT will perform as expected until the next scheduled maintenance operation.

This is why since January 1st 2018, customers are no longer authorized to replace the ELT battery themselves and must contact an approved KANNAD battery replacement center. The Level 2 CMMs are only provided to Kannad Approved Operators and Kannad Approved Battery Replacement Centers.
