IMPLEMENTATION OF NEW CIVIL AVIATION DIRECTIVES EFFECTIVE 1ST AUGUST 2021

1 Introduction

1.1 A Notice of Proposed Rule Making (NPRM) was issued by the Chief Executive Officer (CEO) of the Civil Aviation Authority of Malaysia (CAAM) via a Civil Aviation Notice (CAN) 009/2021 on the 9th of July 2021, in exercise of the powers conferred by section 24O of the Civil Aviation Act 1969 [Act 3], prior to the implementation of the Civil Aviation Directives (CADs) below:




2 Responses

2.2 The graphs below depict the breakdown of the responses received.






Fig 2: Breakdown of feedback based on organisations.




Fig 3: Breakdown of feedback based on industry involvement.

3.1 Upon completion of the review process of all the responses received, amendments were made as required. Some of the notable changes are:
