## REVISED FLIGHT CREW LICENCE

### 1 Introduction

- 1.1 In line with the implementation of CAC 08/2021 Attachment 1, CAAM will begin its process of revising all new and previously issued flight crew licences. The introduction of the revised licence is done so to incorporate changes in line with ICAO Annex 1 SARPs (Standards and Recommended Practices).

### 2 Changes in Licence

- 2.1 The changes will affect the first two pages of the licence, namely the licence particulars, with the main change being the switch from Arabic numerals to Roman numerals.
- 2.2 Licence holders will be issued the revised licence pages when they submit their licence for renewal with the CAAM.
- 2.3 All licence holder when renewing their licence, in addition to the required documents prescribed in CAGM 1001 – FCL, shall prepare the following:
- a) Two (2) driving licence sized photo (25mm width x 32mm height) with blue background
- 2.4 In addition to the signatures and date of expiries, licence holder are to ensure the first two pages of the licence are updated. A sample of the revised licence pages can be found in the attachment of this AI.

*Note. – The remaining pages of the licence shall remain the same*



- 2.5 The change is expected to be progressive and is expected to complete by the end of the year. For additional information on the change, refer to CAC 08/2021 in the CAAM website.
