## IMPLEMENTATION OF NEW AND REVISED CIVIL AVIATION DIRECTIVES AND CIVIL AVIATION GUIDANCE MATERIALS EFFECTIVE 15<sup>TH</sup> NOVEMBER 2022

## 1 Introduction

1.1 The Chief Executive Officer (CEO) of the Civil Aviation Authority of Malaysia (CAAM) has issued 40(forty) revised Civil Aviation Directives (CADs), 12(twelve) revised Civil Aviation Guidance Materials (CAGMs) and 6(six) new CAGMs to provide standards and guidance for flight safety. The CAGMs are provided to support organisations to ensure compliance with the provisions laid in the CAD published in exercise of the powers conferred by section 24O of the Civil Aviation Act 1969 [Act 3].

1.3 Notwithstanding Regulation 204 and Regulation 205 of the Malaysian Civil Aviation Regulations 2016 (MCAR 2016), when the CAGMs issued by the CAAM are complied with, the related requirements of the CADs may be deemed as being satisfied and further demonstration of compliance may not be required.

## 2 Effective Date and Revocation

- 2.1 The CADs stated in the table in paragraph 1 will come into operation on the 15<sup>th</sup> November 2022. These CADs revoke the following:
  - 1) Civil Aviation Circular (CAC) 08/2021 Revised CADs and CAGMs Requirements and Guidance, dated 31 December 2021.
  - 2) Civil Aviation Circular (CAC) 01/2022 Revised CADs and CAGMs Requirements and Guidance, dated 31 January 2022.
  - 3) Civil Aviation Circular (CAC) 02/2022 Revised CADs Requirements and Guidance, dated 10 June 2022.
  - 4) Civil Aviation Circular (CAC) 03/2022 Revised CADs Requirements and Guidance, dated 10 June 2022.
  - Civil Aviation Guidance Material 1823 (CAGM.1823) Guidance for Qualification and Experience of Instructor, Knowledge Examiner and Practical Assessor (PAKE) Issue 01 Revision 00, dated 15 September 2021.
