IMPLEMENTATION OF NEW CIVIL AVIATION DIRECTIVES EFFECTIVE 1ST MAY 2021

1 Introduction

1.1 A Notice of Proposed Rule Making (NPRM) was issued by the Chief Executive Officer (CEO) of the Civil Aviation Authority of Malaysia (CAAM) via a Civil Aviation Notice (CAN) 7/2021 on the 12th of April 2021, in exercise of the powers conferred by section 24O of the Civil Aviation Act 1969 [Act 3], prior to the implementation of the Civil Aviation Directives (CADs) below:

1.2 The purpose of this NPRM was to benefit from the knowledge of pilots, airlines, aviation related training organisations and/or other aviation service providers in the development of these new CADs. This is standard procedure prior to effectiveness of any CAD.

2 Responses

- 2.1 There was a total of 91 responses from 10 organisations received during this NPRM process. Responses, where necessary and requested, were sent out to the relevant organisations that provided the feedback. The last response was sent on the 29th of April 2021. CAAM would like to express our gratitude to all organisations that participated in this rule making process.
- 2.2 The graphs below depict the breakdown of the responses received.




Fig 1: Breakdown of feedback based on individual documents.




Fig 2: Breakdown of feedback based on organisations.




Fig 3: Breakdown of feedback based on industry involvement.

3 Notable Changes

3.1 Upon completion of the review process of all the responses received, amendments were made as required. Some of the notable changes are:

CAD 1201

a) Added requirements on Relieve from ATC Duties (Paragraph 2.12) and Suspension of Licence (Paragraph 2.13).

CAD 6801

a) Airworthiness Consideration (Chapter 11) requirement has been removed.

4 Effective Date and Revocation
