







# **CORRECTIVE MEASURE**

## ROTOR FLIGHT CONTROLS - Collective Pitch Controls Replacement of the switch guard of the "SHEAR" control on the pilot and co-pilot collective sticks

## Summary:

Airbus Helicopters has been informed of a mechanical distortion of the switch guard of the "SHEAR" control pushbutton installed on the co-pilot collective stick. This event was the subject of the publication of the Safety Information Notice (SIN) No. 2736-S-25.

This distortion is difficult to detect and can result in shearing the hoist cable with the mission selector switch in the "HOIST" position if the crew press on the switch guard of the "SHEAR" push-button.

To remove this risk, Airbus Helicopters has implemented modifications 0725C76 and 365P084906.00/02, which consist in replacing the switch guard of the "SHEAR" control push-button on the pilot and co-pilot collective sticks.
