NOTICE OF EXTENSION TO THE APPLICABILITY DATE FOR PARAGRAPHS 2.5 AND 15 OF CAD 6805 – AIRCRAFT MASS AND BALANCE PROGRAMME

1 Introduction

- 1.1 This Civil Aviation Notice is issued by the Chief Executive Officer (CEO) of the Civil Aviation Authority of Malaysia, herein referred to as the Civil Aviation Notice (CAN) 013/2021, in exercise of the powers conferred by section 24O of the Civil Aviation Act 1969 [*Act 3*].
- 1.2 This CAN grants six (6) months extension period for operators to have in place the mass and balance programme as specified in paragraphs 2.5 and 15 of Civil Aviation Directives (CAD) 6805 Aircraft Mass and Balance Programme. For AOC operators, the extension is until 30th April 2022 and for other than AOC operators, the extension is until 31st July 2022.

2 Purpose

- 2.1 Paragraph 2.5 of CAD 6805 Aircraft Mass and Balance Programme states that the operator of an aircraft shall ensure that no flight shall take place unless the mass and balance control of the aircraft is performed in accordance with the approved mass and balance programme.
- 2.2 In addition to that, paragraph 15 of CAD 6805 specifies additional requirements pertaining to operator's mass and balance programme approval.
- 2.3 In order to facilitate the operators on the preparation time needed to establish and implement the mass and balance programme, CAAM through the issuance of CAN 013/2021 grants six (6) months extension period to the mass and balance programme approval requirements as specified in paragraphs 2.5 and 15 in CAD 6805, from the respective effective date in CAD 6805 of 1st November 2021 and 1st February 2022.
- 2.4 Operators are advised to submit the mass and balance programme document for CAAM approval at least 3 months prior to the expiry date of this extension to ensure timely approval.
- 2.5 All other requirements in CAD 6805 remains applicable based on the original effective dates and compliance shall be demonstrated by the operators accordingly.
