Airbus Helicopters updates the Instructions for Continued Airworthiness (ICA) with revisions in a regular and controlled manner at least once a year, in order to avoid additional management by the operators for changes in between.

In addition to these Normal Revision releases, complementary ICAs are provided at each aircraft delivery to complete the ICA set in order to improve its completeness.

The aim of this Delivery Note (DN) is to authorize the advanced distribution of ICA information required by the EASA regulation 21.A.61.

This DN does not replace the next issues of the ICA revisions. The ICA inserted in this DN have to be considered complementary to the ICA already published under the EC120 B Normal Revision available at time of aircraft delivery, and shall be used until incorporation into a future Normal Revision.

This DN is made available to all owners of the affected aircrafts, via the usual distribution means, and in accordance with the aircraft owner subscriptions to Tech Data.

The technical content of this DN is approved under the authority of the DOA ref. EASA.21J.700.
