I - MONITORING OF UPPER FINS P/N 355A.14.0522

Following several cases of cracks experienced in service, a visual inspection for cracks on the visible portions of the flanges of the fin support fitting is to be performed every 10 hours of flight.

This inspection forms the subject of Aerospatiale telex service AS 355 n $^{\circ}$ 05.01 dated 13/10/1981 followed by the release of telegraphic Airworthiness Directive issued by DGAC/SFACT/TC on 15 october 1981 and applicable on receipt.

After incorporation of the modification subject of par. II below (improved installation of fins) the above-mentioned inspection is no longer necessary.

II - IMPROVED INSTALLATION OF UPPER FINS P/N 355A.14.0522 AND LOWER FINS P/N 355A.14.0521

To preclude the risk of cracks developping on the fin support fitting, compliance with the improvement modifications (smoothing down the flanges on the upper fin fitting and unstressed installation of upper and lower fins), described in Aerospatiale S.B. AS 355 n° 55.01 becomes mandatory. Before this operation, inspection for cracks in the upper fin fitting by dye penetrant method is required.
