**Subject: Service Bulletin 13445 on PT6A-52/60A Engine Build Record Status Forms**

**Applicability: PT6A-52 (Serial No. RX0279 onwards) and PT6A-60A (Serial No. PK1229 onwards)**

Pratt & Whitney Canada Corp. (P&WC) issues this Service Information Letter (SIL) to advise operators of certain PT6A-52 and PT6A-60A engines where the Production Build Record Status form may reflect the incorporation of Service Bulletin (SB) 13445 from manufacture. This SB is not applicable to PT6A-52 or PT6A-60A engine models.

SB13445 was released to publish a new configuration of Electronic Limiter Unit (ELUs) for the PT6A-62 engine model only. The PT6A-52 and PT6A-60A engine build standard (bill of materials) does not include an ELU and it is not an applicable configuration for these models.

This inadvertent issue may be evident on build record forms from late 2009 onwards. Although SB13445 may be reflected on the engine build record, this SB is not applicable to PT6A-52 or PT6A-60A models by effectivity. There are no associated technical or physical configuration changes and there is no further action for this SB.

Should SB13445 be evident on the PT6A-52 or PT6A-60A engine build record, per SB effectivity, it may be recorded by the operator as not applicable.
