This Service Information Letter (SIL) is to inform our Asia Pacific P&WC customers that, as part of P&WC's continued efforts to increase spare parts availability and responsiveness, P&WC has appointed VSE Aviation Inc. (VSE) to distribute line maintenance new spares and the exchange of line replacement units effective December 1st, 2022 for all engine models listed in the table below. As the Original Equipment Manufacturer (OEM), P&WC continues to fully support warranty, technical and manufacturing support for engine models listed.

The transition to VSE will be a phased approach by customer region over 2022 and 2023. Customers will be contacted by VSE to be on-boarded and transition into placing new orders with VSE as distribution centers for each region are ready.

In order to ensure a smooth transition, P&WC will be providing publicly available customer information to VSE, such as customer names, addresses and facility ship-to locations in this region as well as contact information to facilitate the on-boarding process within VSE's order management systems.

VSE is a worldwide distributor of aviation products providing 24/7/365 support to aircraft operators, commercial airlines, helicopter operators, general aviation, and maintenance facilities.
