Over the years, Airbus Helicopters has issued a number of technical publications warning its customers against the usage of any alleged "Airbus Helicopters" components sold through outlets not validated by Airbus Helicopters.

With Safety Information Notice SIN 2125-S-00, Airbus Helicopters reminded all operators, pilots and maintenance personnel of the serious risks associated with the sale and usage of used helicopters as well as the usage of parts not produced/delivered by Airbus Helicopters.

With the current Safety Information Notice Airbus Helicopters likes to warn all of its customers that tools that were not provided by Airbus Helicopters or its authorized manufacturers or service centers might be reverse engineered tools not approved by Airbus Helicopters or by any airworthiness authority. They can:

- cause a serious incident on or accident of the aircraft
- adversely, and seriously, affect the airworthiness of the aircraft and that in such event, Airbus Helicopters will not be held liable
- pose a serious risk of property damage, injury and/or death.

This warning applies in particular to tools of

- Measurement, inspection and testing equipment and instruments
- Lifting accessories and devices
- Pressurized tools.

With this Safety Information Notice Airbus Helicopters wants to point out in particular that basically any usage of tools not produced/delivered by Airbus Helicopter or its qualified partners might have unforeseeable effects on the maintenance measures carried out with them on:

- parts
- components
- the aircraft as a whole.

Tools not produced/delivered by Airbus Helicopter or its qualified partners therefore might have an impact on flight safety.
