SUBJECT: Certification Specification 26 (CS26) Issue 4

Helicopters Affected: All AW139, AW169, AW189

Dear Customer.

With the present letter Leonardo Helicopters (LH) would like to inform you that on 19th July 2022, the European Commission issued regulation EU 2022/1254, concerning the introduction of new additional airworthiness requirements applicable when the aircraft is operated over water in accordance with point CAT.IDE.H.320(a) of Annex IV to Regulation (EU) No 965/2012. This led to the issuance of the Issue 4 of Certification Specification 26 (CS-26), on 8th September 2022.

The entry into force of the new requirements has been staggered in 4 years, starting from 09th August 2023; new CS-26 Issue 4 requirements have been analysed and LH is working to develop and certify the modifications needed to comply with them.

For in-service helicopters, dedicated Optional Service Bulletins (139-759, 169-250 and 189-381) are under finalization in order to provide the instructions to implement the configuration changes needed to be compliant with the aforementioned first step requirements. Please find in Annex A the summary of the modifications required for each Helicopter type.

Due to the challenging schedule of entry into force of the new CS26 requirements imposed by the Authority, please find reported in Annex B the SBs part lists with the aim to support the Customers/Operators in reducing the time to procure the parts required by the SBs.

Customers/Operators interested in applying the SBs are kindly invited to place Purchase Orders in advance to the issue of the SBs with the information provided in Annex B; LH will ship the ordered parts as soon as the SBs are issued.

Analysis of the next steps of additional requirements that will be in force in the next years is ongoing and information will be provided through the usual communication channels in due time.
